**VACCINATIONS REQUIRED:** DOGS: DHLLP, Bordatella, & Rabies CATS: FVRCP, FeIV (or negative FELV/FIV test), & Rabies

Meiners Animal Clinic requires Bordatella to be administered every year. If it hasn't been done in the last year, it is in your dog's best interest to have the Bordatella vaccination 14 days PRIOR to your dog entering the facility. If your pet(s) is dropped off for daycare without up-to-date vaccinations your pet(s) will be kept in quarantine away from the other boarding & daycare animals and you will be asked to update vaccines before returning. You may also fill out a treatment consent form to allow us to update those vaccines while your pet(s) is here with us.

**HEALTH:** All dogs must be in good health and must not have been ill with a communicable condition within the last 30 days. All boarding and daycare pets must also be free of internal & external parasites. We require all daycare dogs to either be on year-round heart worm prevention or have an annual negative fecal test result. If your pet has external parasites, they will receive a bath and a topical treatment will also be applied. The pet must also be quarantined away from the other boarding/daycare pets. The additional charges will be added to your final bill.

**BEHAVIOR:** All dogs must be non-aggressive and not toy protective. (Daycare only)

**DAYCARE:** All dogs must have a personality profile filled out to attend. We offer discounted rates for Daycare while your pet is boarding with us.

**SEX:** All dogs that are NOT spayed or neutered must notify us of this if attending Daycare with us.

**AGE:** All dogs must be 4 months of age or older, unless cleared by your veterinarian.

**MEDICATIONS:** Please bring any and all medications or supplements that you would like us to administer to your pet during their stay with us. We have a \$2.00 charge for each time we have to administer any medication to your pet during their stay per day.

**CHECKOUT:** We charge for the day the pet comes in AND for the day pet is picked up unless pet(s) are picked up BEFORE noon on checkout day. Our hours are Mon-Fri 7:30 AM to 5:30 PM, and Sat 8 AM to Noon

**First Time Boarders** – *Charges are payable in advance.* Payment for boarding, daycare, or any veterinary care received while boarding is due at time of service.

Your pet's health is very important to us. Please understand that if your pet becomes seriously ill while

staying here, we will take every measure we can to notify the owner. If we are unable to contact the owner, or if the owner does not inform us immediately regarding measures to be taken, or if the state of the animal's health reasonably demands quick action, we will treat the pet using our discretion and judgement. This includes only necessary diagnostics, non-elective treatments and emergency surgery. Pet owners agree to be responsible for all veterinary costs provided to your pet.

In some cases, pets may develop minor illnesses such as: vomiting, diarrhea, skin wounds/lesions, ear infections, etc. Please indicate if it is ok to treat such illnesses while your pet is boarding or attending daycare with us:

While your pet is staying with us, Meiners Animal Clinic agrees to exercise reasonable care to keep the kennel premises sanitary, the pet properly enclosed in a safe environment, fed properly and regularly, and keep your pet on the premises unless the owner gives consent. All pets boarded are cared for by Meiners Animal Clinic without liability on my diligence on my part for loss or damage from disease, death, running away, theft, fire, injury to persons, other pets, or property by said pet, or other unavoidable causes, due diligence and care have been exercised. I hereby agree to the terms of this contract, and recognize that the provisions of this contract are binding upon both parties, and that this contract contains the entire agreement between the parties. I hereby agree to the foregoing as owner of the pet(s) and that this applies to any and all services provided by Meiners Animal Clinic.

- I understand that I am fully and financially responsible for any harm caused by my dog towards another dog or another person's property while my dog is attending Meiners Animal Clinic. I shall indemnify Meiners Animal Clinic against any claims made against the corporation or losses or damages of any kind suffered by Meiners Animal Clinic as a result of my failure to inform Meiners Animal Clinic of any pre-existing condition the dog may have (such as illness or aggression problems.) I understand and agree that in admitting my dog to Meiners Animal Clinic the facility has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.
- I understand and agree that Meiners Animal Clinic will not be liable for problems, damage, or injury caused by my dog provided that reasonable care and precautions are followed by Meiners Animal Clinic staff. I understand that Meiners Animal Clinic is fully insured. I release Meiners Animal Clinic of any liability arising from my pet(s) attendance. I understand that the daycare is a place where animals co-mingle in groups. I understand that when dog(s) play in group's nicks and scratches may occur. Day care staff may or may not notify me immediately. If the injury is not serious staff may feel it is ok to leave the dog till the end of the day and let me know about it when I pick up. If the injury is serious, I will be notified immediately. I accept all reasonable risks of injury

incurred in normal activity during daycare.

- I understand that a pet that is unclaimed for ten days beyond its scheduled discharge date is considered abandoned and will become the property of Meiners Animal Clinic. Every effort will be made to contact me if abandonment becomes an issue.
- I agree that for the protection of my pet(s), if my pet(s) become destructive, Meiners Animal Clinic reserves the right to confine my pet to their kennel. I, the owner, shall pay any expenses so incurred.

***I represent that I am the legal owner of the animal(s) listed on this contract and to my knowledge can confirm that the animal(s) have not been exposed to Rabies or Distemper in the last 30 days. I agree to pay for services rendered unless prior arrangements are made and approved in ADVANCE. I understand that I am responsible to pay for costs of ALL delinquency charges. Delinquency charges are 50% of the unpaid balance.***
